Should any part or parts prove to be factory defective after ninety days but prior to three years from date of purchase, the part or parts only will be repaired or replaced at your Doughboy Dealer/Authorized Service Center at no charge to the original purchaser (consumer). Labor charges are not covered.

To qualify for warranty work, the consumer must provide the service center with proof of purchase date.

Any item sent to a service center must be shipped prepaid.
